

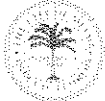

A RESOLUTION OF THE MIAMI CITY COMMISSION, AUTHORIZING THE CITY MANAGER TO EXECUTE A SUBMERGED LAND EASEMENT AGREEMENT ("EASEMENT AGREEMENT"), WITH CORAL REEF YACHT CLUB, A NON-PROFIT CORPORATION ("GRANTEE") FOR THE GRANTEE'S USE OF APPROXIMATELY 4.21 ACRES OF CITY-OWNED SUBMERGED LAND LOCATED WATERWARD OF 2484 SOUTH BAYSHORE DRIVE, MIAMI, FLORIDA, FOR MARINA PURPOSES, PROVIDING FOR THE PAYMENT BY GRANTEE OF THE AMOUNT OF \$1,140,000.00 IN CONSIDERATION FOR THE EASEMENT, WITH TERMS AND CONDITIONS MORE PARTICULARLY SET FORTH IN THE EASEMENT AGREEMENT.

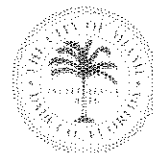
